### INTRODUCTION

The Taylor Independent School District is issuing this invitation to submit qualifications for architectural and engineering services associated with the 2025 bond.

#### PROJECT SCOPE OF WORK

The Taylor Independent School District is seeking qualifications for architectural and engineering services. Services may include, but are not limited to, the following categories:

- 1. Design and planning for future expansions of Taylor High School and Middle School
- 2. Design of a multi-purpose facility with auditorium, performing arts, and flexible instructional spaces at Taylor High School
- 3. Design of additions and renovations at Taylor Middle School, including modernization, science labs, and physical education spaces
- 4. Design of renovations and possible additions for S.T.E.M. spaces at elementary and middle school facilities
- 5. Construction administration
- 6. Future site selection, planning, and test fit
- 7. Additional services as needed

The construction delivery method for these projects is expected to be Construction Manager at Risk.

The construction material testing services necessary for the District's acceptance of the Project will be performed under a separate contract with an independent provider engaged directly by the District.

### **SELECTION PROCESS**

It is the policy of Taylor ISD that the selection of a firm to provide professional services identified herein shall be on the basis of demonstrated competence and on the professional qualifications necessary for the satisfactory performance of the services required. These services are to be obtained at a fair and reasonable cost based on legal requirements.

Taylor ISD reserves the right at any time to reject any or all responses to this RFQ.

### **EVALUATION CRITERIA AND AWARD**

The evaluation will be based on the following:

- 1. Weighted criteria will be used to evaluate the qualifications submitted by responding firms.
- 2. Taylor ISD reserves the right to adjust, add, or remove steps to the evaluation process as deemed necessary for a thorough evaluation of the responses in order to determine the most competent, qualified firm.
- 3. If needed, presentations and interviews may be requested and scheduled at a later date and time.

Taylor ISD will evaluate each Statement of Qualifications Questionnaire submitted to determine responsiveness to the District's needs based on the following criteria:

- 1. **General Information (10 Points)** Review of the firm's general information, including litigation history, financial history, and insurability.
- 2. Personnel (20 Points) Individual firm key employees assigned to the design team must demonstrate personal experience with construction/renovation projects at different levels of complexity. This experience must be represented in each key discipline appropriate to the project scope, including architectural, structural, civil, mechanical, electrical, and technology. It is highly desired that the designated design project manager have extensive experience in construction/renovation projects with varying degrees of complexity and work phasing.
- 3. **Professional Services (15 Points)** Firms must identify professional services provided in-house as well as those that utilize the services of outside consultants. Listings of applicable software to be utilized as well as their benefits to Taylor ISD are to be included.

- 4. **Planning & Design Approach (20 Points)** Provide information on how your firm will work with the District on programming and design.
- 5. **Project Experience (35 points)** The firm's ability to clearly demonstrate its approach to design and construction processes, to promote potential bonds, to render high-quality design services required by the District, as well as bring projects in on budget, including change orders during construction.

Upon evaluation completion, the District will rank all respondents for School Board approval. The District shall attempt to negotiate with the highest-ranked firm. If the District is unable to negotiate a satisfactory contract with the selected firm, the District shall, formally and in writing, end negotiations with that firm and proceed to negotiate with the next firm in the order of the selection ranking until a contract is reached or negotiations with all ranked firms end.

- receives compensation from the business entity for the person's participation;
- communicates directly with the governmental entity or state agency on behalf of the business entity regarding the contract; and
- is not an employee of the business entity or of an entity with a controlling interest in the business entity.
